8.18 Children in the Classroom and on Campus

Decision

On April 11th, 2023 the AGC membership voted to endorse revisions to the 8.18 'Children in the Classroom and on Campus' Policy Statement. The revisions reflect the need to update specific campus locations and the problematic nature of the term 'Minors'.

The existing Policy Statement reads:

III. Policy Statement

- A. Classroom Policy: GRCC prohibits bringing children to class and/or leaving them unattended on campus such as halls, the library, the student center, computer labs, etc.
- B. Campus Policy: Children accompanying visitors, employees, or students of Grand Rapids Community College must be under the direct and constant supervision of a responsible adult while on GRCC campus.
- C. Minors enrolled in GRCC classes are not considered children under this policy.

Below is the new language (with specific changes underlined):

III. Policy Statement

- A. Classroom Policy: GRCC prohibits bringing children to class and/or leaving them unattended on <u>GRCC campuses and controlled spaces</u> such as halls, the library, the student center, *tutorial and* computer labs *and testing centers*.
- B. Campus Policy: Children accompanying visitors, employees, or students of Grand Rapids Community College must be under the direct and constant supervision of a responsible adult while on GRCC campus.
- C. Officially sponsored institutional, programmatic activities for non-students and students under the age of 18 enrolled in GRCC classes are not considered children under this policy.
